As a 'Dales village' the extent and historic nature of immediate village and area should be protected from the intrusion of more modernistic change unless the changes can be accommodated sympathetically without intrusion, not only on the longer term physical appearance of the area but also taking into consideration local people and the level of disturbance and disruption to their wellbeing

More financial support to maintain properties in the Conservation area in an energy efficient way would be great. Some older properties are difficult to double glaze, for example. Many houses have installed UPVC windows, which to my understanding are not aligned with requirements of the conservation area, so rules are not being applied to maintain the historic appearance of Masham. Bins in the street really impact the appearance of the town
